KNOW ALL MEN BY THESE PRESENTS: That we, all of legal age, all of whom are residents of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a charitable, non-profit and non-stock corporation under the laws of the Republic of the Philippines. AND WE HEREBY CERTIFY: That the name of the corporation shall be "International Philippine Philatelic Society, Inc."
